





RESPONSE STATISTICS

Response

Lacey desperately needs more affordable apartments. Right now all the demand for housing is driving the prices up and it is getting out of control. Thank you for trying to figure out a solution.

With the most recent change by the WA State Supreme Court allowing possession of illegal drugs, how will our police force be able to make arrests and do their job policing this issue?

The Homelessness is an issue and the steps taken to cater to these folks is not the answer. These public lands are owned by the public and the public are those who pay taxes especially businesses. The tax payers(owners) should have more right than the homeless whom destroy the beautiful landscape of this city. Taxes pay for Safety and allowing homeless to accosts the public, destroy and degrade our property is not what these taxes were asked to pay for.
