Hi Samra,

I have several concerns regarding the proposed Meridian Market at the corner of Willamette & Campus Glen Drive here in Lacey. The developer appears to be deliberately deceptive with their "Market Narrative" making no mention of a GAS STATION anywhere in the entire document. This is a critically important detail it seems they are attempting to gloss over.

The entire proposal, according to their narrative, is predicated around serving the community with a "farmers market style store" citing the "frustration & difficulty" of currently having to cross over the I-5 freeway to shop for groceries. They specifically state this as the main reason they are wanting to develop this project and "cater to the Meridian Campus community".

There is no logic to this reasoning as construction is already underway on the Hogum Bay Town Center at the corner of Willamette Drive & Marvin Rd NE less than 2 miles from the proposed Meridian Market on the same side of the freeway. The first 2 phases of this new town center include no less than 75,000 square feet of mixed-use commercial, food & restaurant lease space. Furthermore, the proposed market is directly across the street from a city park seasonally full of children running all over the place and shares a property line with single family homes. The last thing we need in Meridian Campus is another market, especially one with a GAS STATION and all of the associated noise, activity and increased traffic that will inevitably come with it.

Better suited to the site would be small commercial spaces available for lease by individual business similar to those a block or two away that include a cafe, coffee shop, dental office, accountant office, etc. A GAS STATION is simply not a good fit at this location given the proximity to the park and nearby homes.

In closing I would like to express my concern for having a public hearing at this stage of the process in the first place. After writing a letter to the hearing examiner's office a family member of mine was informed by someone from said office that the project essentially can not be stopped at this point; that if the city did not move forward with approval it would be against the rules & regulations that previous staff and residents put in place and would be illegal to stop. Furthermore, the city would be sued, challenged in court and subsequently lose. If this is true I fail to understand the logic in having the public chime in this late in the process other than to simply check off a box on the application documents.

Thank you for your time & effort adding my thoughts to the public record.

As I am unable to attend the zoom meeting on April 12th, please forward my email onto the hearings examiner.

As a homeowner in Campus Meadows, I am opposed to having a gas station/convenience store at the corner of Willamette & Campus Glen Drive. This type of business has no place in a residential neighborhood & would negatively impact the livability of our beautiful area.

This business would be directly across the street from a neighborhood park where children & families gather & in close proximity to a middle school & future elementary school. Safety is of major concern. According to a friend of mine who is a former police chief, gas station/convenience stores breed crime. Do we really want to put our children & residents at risk? As a single, senior citizen, I would no longer feel safe in my own home. In all honesty, if this project is approved, I would be forced to move, which would impact me financially.

I'm also concerned about the amount of traffic this type of business would bring. As it is, it's often difficult to navigate that intersection. I was informed the city plans to place a roundabout at that location. I can't imagine tanker trucks trying to make those turns. Or for that matter, driving up & down Willamette,

Recently, there's been a lot of street racing on both Willamette & Campus Glen Drive. Last Saturday evening, there was a single car crash on Willamette involving 3 young people. It was reported they were traveling at a high rate of speed & hit a tree. Having a gas station at the location would attract more young people with less desirable behaviors. Would alcohol be sold?

The environmental impact this type of business would bring is concerning. Why has the city decided no geological study is necessary? This proposed project is in close proximity to a trail & homes. Shouldn't that be taken into consideration? Has the parks department had a say so on this project?

I attended a zoom meeting last spring. Ms. Seymour stated that the developer had a desire to enhance the livability of our community & provide a business that would increase "walk ability." A gas station does the complete opposite. We have enough gas stations in the area & we certainly don't need another one. Especially in a residential neighborhood! As far as the convenience store portion of this business, I don't believe it will be frequented by our community members. It was brought up in one of the studies that a lot of warehouse workers would shop there. With the amount of potential litter, is THAT desirable? I think not & shudder to think of what our neighborhood would look like a year or two from now. Take a



look at the Arco Station on the corner of Marvin & Hawks Prairie. In addition to litter, there's a lot of blue tarps. Again, undesirable & would only decrease our property values.

Please consider the residents of this community when making your final decision. If you've ever driven through this neighborhood, you'll see it's absolutely beautiful. One of tree lined streets & well maintained homes. Where families live & play, living out their dreams. Having a business like this would destroy all we've worked hard for.

Personally, I'm not opposed to having a business at that location. It's the TYPE of business.

(Project #20-310) This is an extremely dangerous proposition due to the increase of vehicle traffic directly across the street from a busy park and at the major intersection where middle school students travel by foot/bicycle to and from Salish Middle School. To the hearings examiner:

As grandparents of two children attending Salish Middle School, we want to express our opposition to the gas station and market being proposed on Willamette Drive. We have been dropping off and picking up our two grandchildren for the last year since school started and I can tell you that during certain hours, there is much pedestrian activity on or near the corner of the proposed gas station. In addition there are times of heavy traffic related to the school. Many children are jay walking and or crossing both Willamette Drive as well as Campus Glen. I cannot imagine cars and tanker trucks pulling in and out of that proposed station and believe that the station poses a safety hazard due to its particular location near the school and the park.

I also believe that the market could be a nuisance to unsupervised students who wander into the store without their parents. We have no control over what merchandise is sold in the market, some of which might not be appropriate for children without their parents. I have seen such markets near schools and they can also become places where students congregate. These are not high school students. They are middle schoolers.

Thirdly, we have at least four stations within 2.5 miles, one of which is Costco. I myself would bypass this proposed station to get the cheaper gas at Costco. I suspect the same would be true for others. There is no community need for a gas station in this location. Given the projection of conversion to electric cars in the next decade, permitting one more gas station seems highly short sighted and not in line with the attempt to reduce carbon emissions by the year 2030.

I would hope the planning committee would balance the many different needs of a healthy community: health and safety, ecology, tree preservation, protection of children and business interests. I trust that the desire of the city to receive taxes from businesses does not take precedence over other very important needs.

Statement to Be Entered into Public Record:

My name is Sarah Daniels and I have been a City of Lacey Parks and Recreation Commissioner for the past four years. Although I do not represent the Parks Board by making this statement, I mention my role since it is this in-depth experience as a Parks Commissioner that, in part, contributes to my reaction to the proposed Chevron gas station and accompanying retail development at the intersection of Willamette Drive and Campus Glen Drive in Lacey.

As a Parks Commissioner, I have learned the significant difference between the sizes and types of parks in Lacey. A facility like the Regional Athletic Complex, for example, would be a natural fit for an adjacent development of retail/convenience offerings, including gas, grab-and-go foods, etc. Even a community park, which is larger by definition, might comfortably incorporate a nearby gas station. However, the proposed location for this Chevron/retail development is directly across from a neighborhood park, Meridian Campus. To introduce a retail establishment that will sell tobacco and alcohol products in immediate proximity to this small park feels irresponsible and certainly invites high-risk situations – likely involving neighborhood minors.

As you will certainly hear from others who live in the neighborhood, the proposed Chevron/retail location is also just two blocks away from Salish Middle School. In addition, the neighborhood park in question butts up against open space owned by North Thurston Public Schools, with that property slated to become an elementary school sometime in the future. Again, that the City of Lacey would even consider allowing a retail establishment that sells tobacco and alcohol products in such close proximity to these populations is alarming.

I respectfully request that you reconsider the location of this proposed development. As a resident very familiar with this particular area, I can say with confidence that there are countless alternatives that could be located further away from an area so highly populated with families and children at play.
