## I. ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE SPECIFICATIONS

<u>ITEM NO. 1:</u> Special Provisions – Part D, Page 26

1) The revisions include modifications to the Description of Work.

**REVISE** this section as follows (added text is italicized):

"This contract provides for construction of (7) wastewater lift station control cabinet awnings and (1) Kiosk Awning to include:

LS-14, LS-42, LS-44, LS-45, LS-48, LS-50, LS-52 and the Museum Kiosk as shown on plans and as-built drawings."

#### ITEM NO. 2:

# Special Provisions – Part D, Page 54, Section 2-02.5

2) The revisions include modifications to Part D, Section 2-02.5.

**DELETE** this section in its entirety and **REPLACE** with the following:

"The work described in this section shall be considered incidental to the project and no other compensation will be allowed."

#### ITEM NO. 3:

# Special Provisions – Part D, Page 56, Section 7-22.5 Payment

3) The revisions include modifications to Part D, Section 7-22.5

**DELETE** this section in its entirety and **REPLACE** with the following:

#### 7-22.5 Payment

#### (February 14, 2023 Lacey GSP)

Payment will be made in accordance with Section 1-04.1, for each of the following bid items that are included in the proposal.

"Cabinet Awning", Per each.

The unit contract price per each for "Cabinet Awning" shall be full compensation for all labor, materials and equipment required to provide and install the control cabinet awning up to and including foundation base plates as shown on the Plans, and these Special Provisions.

"Kiosk", Per each.

The unit contract price per lump sum for "Kiosk Awning" shall be full compensation for all labor, materials and equipment required to provide and install the Kiosk Awning up to and including foundation base plates as shown on the Plans, and these Special Provisions.

"Foundation", Per each

The unit contract price per lump sum for "Foundation" shall be full compensation for all labor, materials and equipment required to provide and install the reinforced concrete foundation(s) for each awning, regardless of foundation option selected, up to and including the base plate mounting hardware as shown on the Plans, and these Special Provisions.
