## GENERAL INFORMATION

The City of Lacey is organized under the optional municipal code (Chapter 35A.63 RCW) as a Council-Manager form of government. The city fully plans under the Growth Management Act.

Lacey is the largest and fastest growing city in Thurston County, having exceeded its 2035 projected population. The city adopted GHG emissions reduction goals in 2021 through the Thurston Climate Mitigation Plan. The city will adopt new climate sub-elements per Growth Management Act requirements.

### SCOPE OF SERVICES

The consultant will provide support services to the City of Lacey to prepare a climate subelement under the requirements of RCW 36.70A.070(9) for the full update to the Comprehensive Plan.

The consultant will support City staff throughout 2024 and 2025 to update and design its climate resilience sub-elements including creating goals, auditing plans/policies, and conducting a vulnerability and risk assessment, this contract will be terminated by June 30, 2025 or when the consultant has met all of the contract deliverables.

Specific tasks expected from the consultant include:

- Explore climate impacts to the community which includes:
  - o Identifying all community assets.
  - o Identifying climate hazards and climate changes for our region.
  - Pair the assets and hazards to identify exposure and consequences of climate change.
  - o Identify priority climate hazards to address in the climate resilience sub-element.
- Audit current plans and policies through a climate lens and look for opportunities to update any plans that include gaps in climate hazard planning.
- Conduct a Vulnerability and Risk assessment.
- Develop goals and policies related to climate resilience to be included in the comprehensive plan update.
- Develop draft amendments and regulations to the Comprehensive plan in line with Washington's Climate Law for the Growth Management Act (HB 1181).
- Prepare a code audit of existing amendments and those necessary to implement HB 1181.
- Develop an outreach strategy, coordinated with the update to the Comprehensive Plan, that supports environmental justice and conduct stakeholder outreach for both climate resilience and GHG reduction goal setting.

# STATEMENT OF QUALIFICATIONS CONTENT

The SOQ should be provided in Adobe's Portable Document Format, be no more than ten (10) pages in length, and include the following information:

- 1. Name and contact information.
- 2. Curriculum Vitae of the consultant and the project team who would provide support services to Lacey.
- 3. A detailed description of the consultant's experience conducting vulnerability and risk assessments, developing climate goals and policies, and engaging stakeholders with a focus on equity.
- 4. A description how the consultant will keep City staff informed and engaged throughout the contract period.
- 5. Three (3) examples of documents (digital examples preferred) prepared by the consultant.
- 6. Three (3) professional references with personal knowledge of work and experience that demonstrate the ability to provide effective sub-elements for comprehensive planning purposes.

# **SELECTION PROCESS**

Statements will be reviewed and evaluated by considering the quality of experience, strength of the approach, and the responses to the RFQ.

If necessary, consultants may be invited to interview with the evaluation panel. Based on the SOQs and/or interviews, the selection panel will recommend to the City Manager the firm which, in its opinion, best meets the requirements set forth in this Request for Qualifications and negotiate a professional services agreement.
